Opening Prayers & Concerns:

Mother Jenny opened the meeting at 3:30 pm with prayer.

Approval of Minutes:

Vestry Meeting Minutes for July 23, 2024. Motion to approve, Rob. Second, Linda. All in favor.

Rector Report: The Rev. Jenny Scott-Jones

Mother Jenny shared that she is meeting with people and listening to the visions we have regarding the future.

Father Lind is stepping back as Consultant to the Vestry but will be engaged and connected as a coach/mentor to Mother Jenny.

The lighting in the Sanctuary needs to be updated as there are on-going issues and the current lights are outdated and no longer available for purchase. A request for special contributions to replace lighting will be published in the weekly bulletin.

Thrift Store Report: Eileen Carrara

Eileen reported that August has been better than August of last year (\$10,000 ahead).

The "Men's Mission of Fort Myers" has been added as a new ministry to assist. Clothing items are now being distributed to them.

The suggestion was made that we create a giving tree this year for children at "All Souls" ministry.

Motion to approve, all Vestry members.

Finance Report: Joe Mulino

The financial report was emailed to Vestry prior to this meeting.

Joe reported that he recently signed the renewal for a line of credit through First Citizens Bank for \$40,000 that's available now until August 2025.

The lease at the Thrift Store is a "triple net lease" that contains CAM charges. Iona-Hope's share of back-charge is \$12,881 and will be paid in September. Motion to approve, Deb. Second, Linda. All in favor. Negotiations for lease renewal for 2025 will be held in the first quarter. Columbarium:

When a niche is sold, there are three different accounts that the money goes to. Joe is requesting that two of the titles be changed.

He would like the Columbarium Investment Account (Restricted) be changed to Columbarium Purchase of Future Niches.

He would also like Columbarium Niche purchase (Restricted) to be changed to Columbarium Maintenance.

Suggestion to change the account allocation to \$500 to the purchase of future niches, \$500 to maintenance, and \$300 to repay negative balance in the capital campaign.

Motion to approve, Marcia.

Margaret inquired as to whether the current sale Columbarium niches through the end of August should be extended.

All concurred that the sale should be extended through the rest of 2024. Motion to approve, Deb.

Second, Linda.

All in favor.

Rob voiced Columbarium maintenance concerns and suggests further discussion and direction on how to properly maintain.

Perhaps a new committee/position is in order.

Rob, Marcia, and Andi volunteered to pursue/research further.

Church Insurance:

Insurance is increasing by \$6,000 for the next year.

Paula requested a motion to reduce policy costs for not having a "named storm" deductible and "All other peril" deductible to be removed for a cost savings.

The matter was tabled until the next Vestry meeting.
